

# Nursing (BSN) Licensure Disclosures

## What is this document?

Saint Francis University's Bachelors of Science in Nursing program is accredited by the Commission on Collegiate Nursing Education and is designed to meet **educational** prerequisites for applicable licensure/certification in the Commonwealth of Pennsylvania. Requirements for licensure vary from state to state. This document indicates SFU's most recent evaluation of whether its BSN program meets the educational prerequisites required for licensure in each state.
