Coordination with English Department personnel on ELL instruction. Encouragement and support in study abroad opportunities. Clinical experiences in varied setting over four years. An advisory panel from regional schools that share their needs with the university. The Education Department has a collaborative relationship with area schools that is anchored by the Professional Advisory Committee. This committee meets yearly to solicit feedback regarding program students and graduates, and to understand the needs of school districts. Feedback about the quality of our students' program is also gained through the contact that Internship and student teaching field supervisors. Educators from area schools serve as adjunct professors and guest speakers, which gives students an authentic link to challenges surrounding children with disabilities, low income students, and limited English proficient students. Ms. Shaw director of the CARES program which offers social programing to children on the Autism spectrim. University students plan and deliver small group instruction in social skills and maintain classroom management by incorporating behavior interventions, under the supervision of Ms. Shaw. Also students from the University participate in a RTI program in a district with a significant Title I population. In addition to specific courses regarding students with disabilities and English Language Learners, concepts about instructing these students are embedded in core courses, such as Education Foundations. Educational Psychology, and Methods.

Instructional media use is integrated into all methods courses where students evaluate existing programs, design programs, compile information, present information and communicate effectively both in the classroom setting and beyond. Students work with the Standards Aligned Systems, E-metrics, and other PDE tools to develop skills in data-informed instruction. A new course EDUC 225: Assistive and Instructional Technology was added to the course sequence. This course has a dual focus: the use of technology to facilitate instruction in a diverse classroom, and assistive technology available for students with diverse needs. An introduction to the characteristics of 21st century students and classrooms will be presented through exploration of the framework developed by the Partnership for 21st Century Skills. Students will use technology as a tool to effectively modify and supplement instruction. They will select, design, and use technology, materials and resources required to educate students whose disabilities interfere with communication, learning and/or daily living. Students will be required to demonstrate and understanding of the range and the appropriate use of assistive technology (i.e., no tech, low tech, high tech). Four hours of clinical experience includes attendance at the annual Tech Expo sponsored by CERMUSA, the Assistive Technology Expo sponsored by PATTAN, or a similar event. Students will complete four hours of field experience in an area school or educational setting.

At the current time, students above sophomore level are enrolled in a dual certification program which includes classroom instruction related to disabilities, as well as, field experiences. Current freshman and incoming students are not in dual certification but do receive nine credits in special needs and three in ELL. In addition, concepts of differentiated instruction and ELL are integrated in to Methods courses.

In the Special Education certification programs offered by the Saint Francis University Education Department, students will receive training, including classroom instruction and related field work to address the needs of diverse learners. The Early Childhood/Special Education and the Middle Childhood/Special Education dual required candidate competencies for the Special Education PreK-8 certification. Students receive specific classroom instruction and fieldwork opportunities directly related to participation as a member of individualized education program teams, as defined in the IDEA. For example, in EDUC205 Introduction to Special Education, students are introduced to the structure and implementation of an IEP, and the responsibilities they will have as teachers who will be part of the IEP team. In EDUC305 Secondary transition and IEP Content, students construct an IEP, including a transition plan, for hypothetical students. They defend the IEP in a mock IEP meeting. In EDUC405 Low Incidence Disabilities, students create and defend an IEP for a case study student with a severe disability. In EDUC315, students are introduced to the FBA process. They conduct a simple FBA on a case study student and create a Behavioral Intervention Plan with a Measurable Annual Goal addressing a problem behavior identified in the FBA. Pre-service teachers receive instruction in meeting the needs of students who are English language learners in EDUC261 Linguistic Diversity in the Classroom (3 credits). All of the competencies in PDE's Accommodations and Adaptations for Students with Disabilities in an Inclusive Setting and Meeting the Needs of English Language Learners Program Guidelines are met in EDUC261 as well as several other courses. Students spend from 4-15 hours working with students in the field for every Education course, where they connect classroom content to real life experience.
