The tables will be turned as you will become the minority, as a person who is not Deaf. Everything will be expressed in ASL and you will not use your voice the entire trip!

CREDITS

This program will

ASL401: ASL Immersion Experience (3 credits) Offered during both the Spring and Summer semesters

COURSE DESCRIPTION: A six-week on-line course that includes an off campus summer ASL immersion experience. Pre-requisites: Courses*- ASL112: Beginning ASL I & II, ASL201: Intermediate ASL I or ASL 203 Medical Sign, *ASL250: Advanced Fingerspelling and Numbers (*Or permission from the instructor). A Minimum of B- (80%) average in ASL 250 and ASL 201 or ASL 203 is required to declare a minor in ASL.

TRAVEL TO/FROM U.S. AIRPORT

The group departure will be from Pittsburgh Airport. Transportation to/from the airport will not be provided. However, if you would rather depart from an airport closer to your home, please provide the airport information on the application (on back) and arrangements will be made in order for everyone to arrive at the destination approximately the same time (additional costs may apply).

Cell Phones/Laptops

Electronics should be left at home. "Unplugging" for the week will enable students to truly embrace the experience and keep their voices off. Students may give an email address to the Office for Study Abroad. Contacts will be emailed upon arrival.

COST

The program fee is \$3,000 plus tuition. The fee includes:

- Airfare & airport transfers in the Dominican Republic
- food & beverages (including three meals per day, plus snacks)
- daily activities program
- daily entertainment and shows (with PDT Interpreters)
- nine on-site restaurants offer complete meals
- five swimming pools
- . Mangrove Forest with ecological park
- entertainment program including Merengue dance classes, aerobics, aqua-aerobics, beach volleyball, archery, climbing wall, batting cage, table-football, ping-pong, darts, chess, and table games
- four flood-lit tennis courts and three paddle tennis courts
- non-motorized water sports including kayaks, windsurfing, catamaran, snorkeling and pedal boats
- in-room fridge restocked daily with soft drinks and water
- all hotel taxes, gratuities and service charges
- unlimited golf at Cocotal Golf Course (mandatory cart fee not included
- scheduled sign language interpreting service provided by Passages Deaf Travel

PLEASE NOTE: This is an academic course full of non-stop good, old fashion fun with late nights and early mornings. Therefore, students are prohibited from consuming alcohol at any time.

Not included: tuition for ASL 401

A \$300 non-refundable deposit must accompany the application (on back) by June 1st. The total is due December 1, 2019. See withdrawal policy on back.

Requirements to Study Abroad

At the time of application students must have a 2.7 GPA for the semesterlong program or a 2.5 GPA for any of the short-term programs (anything lower requires approval from the program director). Passing grades (C or better) in key subject areas may also be required. Students must have successfully completed at least one semester, and preferably one year, at Saint Francis University before studying abroad. Students must demonstrate emotional stability and maturity and indicate the ability to lead a responsible and healthy life abroad as a representative of the U.S. and Saint Francis University. Students must submit the application and all travel forms to the Office for Study Abroad (see application process below) before acceptance into any study abroad program will be considered. Previous health, academic, or disciplinary problems, may influence the decision.

Study Abroad Withdrawal Policy

Withdrawal from any Saint Francis University study or service abroad program must be made in writing and delivered to the Office for Study Abroad in person (Scotus 205) or certified mailed (Saint Francis University, Office for Study Abroad, P.O. Box 600, Loretto, PA 15940). The date in which the withdrawal is received at the Office for Study Abroad will determine the amount of refund.

If you withdraw or are withdrawn from your study abroad program you will receive a refund minus: non-refundable application fee, any nonrecoverable portion of the airfare, any non-recoverable program costs such as housing payments and deposits, excursion pre-payments, etc. (The closer the program is to the start date, the less recoverable costs will be available). Student withdrawals are not accepted after the start of a program.

If you withdraw from the study abroad program, it is also your responsibility to withdraw from your study abroad courses.

Withdrawals from a study abroad program due to lack of passport and/or visa are held to the same withdrawal policies.
